1. Course Description and Objectives

ECON4901E is a student-oriented course and it aims to introduce the basic skills of conducting economic research and developing a student's ability on the analysis of economic problems. The course is divided into two parts. The first part contains two workshops that focus on research methodology and use of economic data. The second part involves lectures (conducted in English), classroom discussion, and presentation of research projects. With this format, students are expected not only to gain basic knowledge in the design of an appropriate research project but also to improve their public speaking and overall writing abilities.

3.1 Attendance and Class Participation

All students are required to attend all the final presentations. Students are encouraged to participate actively in class discussions. Each student will be assigned one presentation to discuss.

3.2 Consultation Participation

Each consultation session will be 20 minutes and the schedules will be posted in the Discussion Board at the CUHK Blackboard system. Each student must attend a minimum of two consultation sessions, and is limited to a maximum of four consultation sessions. Students should set up the two compulsory consultations before 22 September, with the first consultation being scheduled on or before 16 October and the second consultation on or before 6 November. For consultation sessions other than the compulsory ones, students should sign up before 5pm the day before the consultation. Extra appointments can be scheduled upon request only if all the available consultation sessions are signed up. However, students need to email the instructor at least three days in advance to request an extra appointment.

3.3 Presentation

The schedule and the order of the presentation will be determined in the first class. Each presentation will be no more than 20 minutes in length, followed by a 5-minute discussion and a 5-minute Q&A. The presenter must upload a presentation draft to the Discussion Board at least 48 hours before the presentation, and upload the final presentation slides to the Discussion Board immediately after the presentation.

3.4 Final paper

The final paper should be between 10 and 20 pages in length (excluding tables, figures, and references). To ensure consistency in the format, the main text of the paper should comply with the following format:

The deadline for the final paper is 6:pm on 11 December 2017 (Monday). Students are required to submit both hardcopy and softcopy (via VeriGuide) of their paper to the instructor. Late submission will have 20% of the mark deducted per 24 hour period or proportion to a 24 hour period that it is late. A paper submitted more than 4 days (96 hours) after the due time will receive a zero mark.
