## **Course Description:**

A general survey of the theory and empirics of international trade and an examination of its relation to both international and domestic policies. Major topics include: the theory of comparative advantage, international trade and factor prices, income distribution, economic development, instruments of trade policy and economic welfare.

#### **Course Prerequisites:**

Students should have knowledge of elementary differential calculus, and are advised to take ECON2011 and 2021 before taking this course.

#### **Recommended Text**

Krugman, Obstfeld, and Melitz (**K**), International Economics: Theory and Policy, 10<sup>th</sup> edition.

Feenstra and Taylor (F), International Economics, 3<sup>rd</sup> edition.

Note: No textbook is required for this class, but these two books are recommended if you would like a textbook treatment of the material. Other editions of the books will contain similar material but the syllabus below lists chapter references for the editions listed above.
