Course Overview: The course is an overview of the nature of academic economic studies. Concepts, analytical tools, and theories commonly used by academic economists will be introduced. The course will discuss how decisions are made by consumers, firms, and governments in societies from an economic perspective. The course will cover a wide range of economic topics.

Learning outcomes: Students are expected to 1) explain and interpret daily events from an economic perspective; 2) apply tools and concepts covered in the course to solve simple daily problems; 3) be able to evaluate economically (i.e. logically and rationally) daily issues.

Learning activities: Students will be guided to apply economic tools and concepts to explain/solve a student-selected event/problem encountered.
